Any trace impurities are not expected to be present in levels above the limitations specified by Directive 2011/65/EU and amendments on the restriction of hazardous substances in electrical and electronic equipment (RoHS), specifically Cr+6, Hg, Pb, PBB, PBDE, DEHP, BBP, DBP, DIBP should not exceed 1000 ppm (0.1%) and Cd should not exceed 100 ppm (0.01%)
